RE: REQUEST FOR REVIEW BY THE SPECIAL PROCUREMENT OVERSIGHT COMMITTEE (SPOC): TENDER NUMBER COG/FA/02/05/2024 - PROCUREMENT OF TONER CARTRIDGES USING FRAMEWORK AGREEMENT

Your minute dated 15 August 2024 refers.

At the Special Procurement Oversight Committee (SPOC) Meeting No.30 of 2024 held virtually on 5 September 2024; Members observed the following:

- The Accounting Officer's procurement process was for the Procurement of Toner Cartridges under Framework Agreement and Subsequent Call-off Contract.
- The Accounting Officer adopted the Framework Agreement method in line with section 21(2) and section 30 of the Public Procurement and Disposal of Public Assets (PPDPA) Act [Chapter 22:23] as read with section 11 of the PPDPA (General) Regulations whereby suppliers will be engaged through call-off orders on an as and when required basis at varying prices.
- The Accounting Officer advertised the tender in line with section 38(2) of the PPDPA Act and 3 x bidders responded.
- The Accounting Officer evaluated the tender in line with the Standard Bidding Document and 2 x bidders were disqualified for failing to meet mandatory requirements and 1 x bidder met all the tender requirements.
- The Accounting Officer was of the view that the prices quoted by Ovacoda Investment P/L were on the high side and entering into framework agreements with the bidder would not result in the attainment of public procurement objectives as stated under section 4 of the PPDPA Act.
- The Accounting Officer was recommending to cancel the tender due to non-responsive bid in view with section 42(1) (d) of the PPDPA Act when in fact there was a responsive bid on the process.
- The Accounting Officer should have considered to shortlist the bidder since award will be done using call off contracts at the secondary stage where due diligence will be conducted and further to that since this was an open framework the Accounting Officer had room to enroll additional bidders on the process thereby subjecting the bidder to more competition.
- Members agreed that the Accounting Officer should proceed to shortlist the bidder that responded since award will be done using call off contracts and contract price could be negotiated for at the secondary stage.
