Chairperson`s Opening Remarks

The meeting was convened to discuss the purchase of 800 bags of cement for Nxele, Nkedile, Majojo, and Ingwizi Growth Points, with quotations sourced from various suppliers. The list of suppliers who submitted quotations is as follows:

Preliminary Evaluation of Suppliers:

A preliminary review of all suppliers revealed that certain suppliers submitted expired NSSA Compliance certificates, which were required to be valid. The suppliers with expired certificates, listed below, were disqualified from further consideration:

1. TRYKNODGE Investments (Private) Limited (validity: 25 Jan - 31 Mar 2024)
2. Avenir Landmark Solutions (validity: 29 Aug - 30 Sept 2024)
3. Tian Zim Investments (validity: 01 Apr - 30 Jun 2024)
4. Popmate Distributors (validity: 01 Jul - 30 Sept 2024)
5. Tanaka Macmillan Enterprises Pvt Ltd (validity: 01 Jul - 30 Sept 2024)
6. Prompt Supplies (Private) Limited (validity: 01 Jul - 30 Sept 2024)
7. Cholewick Investments (validity: Jan 2022 - Mar 2022)
8. Tsalaki Investments (validity: 01 Jul - 30 Sept 2024)

These suppliers were aware of the requirement for valid NSSA Compliance certificates but submitted expired ones, which led to their disqualification as outlined in Circular No. OPS/1 of 2023. As a result, their bids were considered non-compliant.

This action is in line with the need to ensure compliance with legal and regulatory standards, and to maintain the integrity of the bidding process.

Evaluation of Financial Proposals and Delivery Schedules:

The evaluation committee assessed the financial proposals and delivery schedules for the cement supply, with specific attention to the 7-day delivery requirement from the award of the contract and the issuance of the purchase order.

Comments

- Eunidar Investments Pvt Ltd submitted the lowest-priced financial proposal, which included transportation to all required sites in Mangwe.
- They also proposed a 5-day delivery period, which was ideal given the urgency of the cement delivery requirement.

Based on the competitive pricing and the quicker delivery timeframe, Eunidar Investments (Pvt) Ltd was determined to be the most suitable supplier for this contract.

Recommendation:

1. Awarding the Contract:
The contract for the supply of cement should be awarded to Eunidar Investments (Pvt) Ltd. Their bid was the most competitive in terms of pricing, and they offered a 5-day delivery period, which met the urgent delivery requirement.

2. Disqualification of Suppliers with Expired NSSA Compliance Certificates: Suppliers who submitted expired NSSA Compliance certificates were disqualified in accordance with Circular No. OPS/1 of 2023, which mandates the disqualification of bids with expired documents. This decision ensures compliance with the regulatory framework and maintains the integrity of the bidding process.
