The committee noted the following,

- The committee had noted that Bid 2: Minerva Insurance has the lowest pride after financial evaluation but had not stated price breakdown.
- In terms of Section 48 of the PPDPA Act, the committee requested that Minerva clarify on the price breakdown.
- Minerva Risk Solutions responded with clarity on the price breakdown.

#### RECOMMENDATIONS

The Evaluation Committee having evaluated the tender in line with the requirements of the bidding document and provisions of the PPDPA Act and Regulations is recommending that **Tender NHS NCB 04/2024** for the Provision of Motor Vehicle Insurance Services be awarded to **Minerva Risk Solutions** the lowest compliant bidder to specifications at an annual total cost of **US\$22,824.00**.




