#### 1. BACKGROUND

The Airports Company of Zimbabwe (Private) Limited (ACZ) adopted a competitive procurement method for the Request for Proposals for the Provision of Legal Services which was published in the Government Gazette of 14 February 2025 and the Electronic Government Procurement (e-GP) portal on 4 March 2025. The request for proposals was advertised through Procurement Reference Number: ACZ/0030/2025. The tender closed on the 22 April 2025. 89 Bidders were invited to participate, 35 Bidders downloaded the tender, and 14 Bids were received from the following tenderers:

In compliance with Section 27(1) and (2) of the PPDPA, the Airports Company of Zimbabwe (Private) Ltd detailed the technical property requirements for the Provision of Legal Services; procurement reference no.: ACZ/0030/2025.

Bidders were notified in the bidding document that the Evaluation of the Proposals would be done in compliance with Section 4(1) of the PPDPA to ensure the achievement of transparency, fairness, honesty, competition among Bidders, fair and equitable treatment of all Bidders, promotion of integrity, achievement of environmental, social and economic requirements of the procurement law.

Bidders were also advised that the successful Service Provider (s) would be required to enter into a contract with ACZ which would conform to the requirements of sections 78 to 89 of the PPDPA.

#### 2. PREPARATION OF BIDS

Only consultants registered with the Procurement Regulatory Authority of Zimbabwe (PRAZ) in terms of Section 4 of the Regulations were eligible to participate.

Consultants were requested to submit Proposals to provide the consulting services as detailed in the Statement of Requirements by submitting separate technical and financial proposals, as detailed below. Bidders were notified that the standard forms contained within the Request for Proposals could be retyped for completion, but they were responsible for their accurate reproduction.

Consultants were advised to read carefully the complete Request for Proposals document, including the Special Conditions of Contract (SCC) in Part 3, as well as the Contract Agreement and the General Conditions of Contract (GCC) for Consultancy Services (available on the Procurement Regulatory Authority of Zimbabwe (PRAZ) website), before preparing their proposal. Part 3:





Contract Agreement was provided not for completion at this stage but to enable Consultants to note the Contract terms they would enter into if their bid is successful.

#### 2.1 Preparation of Technical Proposals:

Technical proposals should contain the following documents and information:

- The Technical Proposal Submission Sheet in Part 1 of the bidding document;
- A brief methodology for performing the services;
- A workplan, showing the inputs of all key staff;
- CVs of key staff who will be handling ACI Cases (attached CVs);
- A summary of your experience in similar assignments, together with the names and contact details of persons
  connected with these assignments;
- Current Practising certificates for all Legal Practitioners operating under the law firm (Attach Practising Certificate);
- A minimum of five (5) years' experience for the managing partner in legal advisory corporate, civil and criminal litigation, notarial and conveyancing services;
- · Partnership deed or agreement;
- Proof of registration as a legal practitioner, notary public and/or Conveyancer.

#### 2.2 Preparation of Financial Proposals:

Financial proposals should contain the following documents and information:

- The Financial Proposal Submission Sheet in this Part;
- The Breakdown of Contract Price form in this Part, showing all costs for the assignment, broken down into fees and reimbursable costs;

#### 3. ELIGIBILITY AND QUALIFICATION REQUIREMENTS

Bidders were required to meet the criteria in section 28 of the Act and section 28 (1) of the Regulations to be eligible to participate in public procurement and to be qualified for the proposed Contract. They were therefore requested to indicate that they;

- 1. have the legal capacity to enter into a contract; Bidder is requested to attach
  - copy of CR14/CR6 form/ Partnership agreement,

- ii. copy of Certificate of Incorporation
- iii. Valid NSSA Clearance/ Compliance Certificate
- 2. Not be insolvent, in receivership, bankrupt or being wound up, not have had business activities suspended and not be the subject of legal proceedings for any of these circumstances; **Bidder is required to attach Appendix C: Declaration Form.**
- 3. not have a conflict of interest in relation to this procurement requirement; **Bidder is required to attach Appendix C: Declaration** Form.
- 4. Not have, neither they nor any of their officers, in the five (5) years immediately preceding the initiation of the procurement proceedings: who have been convicted in any country of an offence related to their professional conduct or the making of false statements or misrepresentations as to their qualifications; or who have been censured or subjected to any penalty in any country following disciplinary proceedings arising out of any conduct involving the making of false statements or misrepresentations; Bidder must attach letter of good standing and registration certificate for the Legal Practitioners, from the Law Society of Zimbabwe.
- 5. Not be debarred from participation in public procurement under Section 72 (6) of the Act and Section 74(1) (c), (d) or (e) of the Regulations or declared ineligible under Section 99 of the Act; **Bidder is required to attach Annexore A:** Secturation Form.
- 6. Have been registered with PRAZ under Category \$1003 and have paid the applicable Registration Fee cot out in Part III of the Fifth Schedule to the Regulations; Bidder is required to attach a valid Proof of Registration with PRAZ registered under category \$1003 for Legal Services
- 7. Have at least three (3) letters of trade references from reputable institutions where similar services were provided within the past two (2) years; the trade reference letters shall be on clients' letterheads confirming that the consultant has performed relevant services (Provision of Legal Services) in the past;
- 8. State a bid validity period which must be at least 90 days.
- 9. Attach detailed company profile.

#### 4. LOTS AND PACKAGES:

The requirement was divided into Lots in accordance with regional areas where ACZ's airports are situated as follows:

- Lot 1 Harare and Kariba
- Lot 2 Victoria Falls and Hwange

- Lol 3 Masvingo and Chiredzi
- Lot 4 Bulawayo

Bidders were allowed to bid for all Lots, but were notified that award would be spread to more than one (1) Bidder per Lot. Bidders were notified that if one (1) Bidder would be successful on more than one (1) Lot, ACZ reserved the right to award if it is deemed to add value to the procuring entity. The award will be stipulated as follows:

- Lot 1 x 3 Firms
- Lot 2 x 2 Firms
- Lot 3 x 2 Firms
- Lot 4 x 2 Firms

#### 5. EVALUATION OF PROPOSALS:

The evaluation of proposals will use the **Quality and Cost Based Selection** (QCBS): evaluation methodology was detailed below:

Quality and Cost Based Selection (QCBS):

- i. Preliminary examination to confirm that all documents required have been provided, to confirm the eligibility of consultants and to confirm that the Consultant has accepted all terms and conditions without material deviation or reservation;
- ii. Technical evaluation to assess the technical quality of proposals against the criteria below, to determine the technical score for each proposal and to determine which proposals reach the minimum technical score given below; and
- iii. Financial evaluation to determine the financial score of each proposal, to weight the technical and financial scores and to determine the total score of each proposal.

Proposals failing any stage will be eliminated and not considered in subsequent stages.

#### 5.2 FINDINGS

The evaluation and contract management committee made the following findings:

- > 10 out of 14 Bidders complied with the requirements for eligibility and qualification criteria of the tender.
- > The following Bidders were not compliant with the requirements: -

#### (a) Makuwaza & Gwamanda Attorneys


The Bidder was requested to clarify in their name; on other documents it was Makuwaza & Gwamanda yet on their NSSA Certificate it was Makuwaza and Magogo. They clarified that they used to be Makuwaza and Magogo, but NSSA was still to adopt the current name.

The Bidder failed on the requirement for Bid Validity period. The Bidder did not state in their bid. The Bidder was therefore disqualified on that basis.

#### (b) Chasi Maguwudze Legal Practice

The Bidder did not submit their Partnership Deed; they were requested to submit in line with Section 47 of the PPDPA Act. The Partnership Agreement was submitted, and they became compliant. They submitted a letter of good standing from the Law Society of Zimbabwe dated 2022. On Individual Partners, the Bidder did not submit letters of good standing and practising Certificates. The Bidder also failed on the requirement for Bid Validity period which was not stated. On their trade references, the Bidder submitted two (2) that were compliant instead of the required three (3) references.

The Bidder was therefore disqualified on that basis.





#### (c) Mushoriwa Moyo

The Bidder submitted a NSSA certificate that expired during the bidding period. Section 47 of the PPDPA Act was applied and they submitted a valid certificate and became compliant.

The Bidder submitted one (1) reference that was compliant on timeframes instead of the required three (3) references. The bidder was then disqualified on that basis.

#### (d) Mahembe Attorneys

The Bidder did not have a partnership deed because they are in sole proprietorship. It made them a risky supplier in case the service provider faces challenges, there will not be continuity. The Bidder was not recommended for further evaluation as they failed to meet the required criteria.

The above four (4) Bidders were disqualified for further evaluation.

#### PMU REVIEW MEETING HELD ON 24 JUNE 2025

The Procurement Management Unit (PMU) received the Evaluation Report on 23 June 2025 and carried out the review of the Evaluation and Contract Management Committee's findings and recommendations on 24 June 2025.

#### BACKGROUND

The Airports Company of Zimbabwe (Private) Limited (ACZ) adopted a Competitive Bidding method for the Request for Proposals for the Provision of Legal Services; Procurement Reference Number: ACZ/0030/2025. The tender was advertised in the Government Gazette of 14 February 2025 and published on the electronic Government Procurement (e-GP) portal on 4 March 2025. The tender closed on 22 April 2025. 14 bids were received from the following Bidders:

- 2. Coghlan Welsh and Guest Legal Practitioners
- 3. Makuwaza and Gwamanda Attorneys

# 14. Maposa Mahlangu Attorneys

In compliance with Section 27(1) and (2) of the Public Procurement and Disposal of Public Assets (PPDPA) Act, the ACZ detailed the requirements for the Request for Proposals through Procurement Reference Number ACZ/0030/2025.

The Bidders were notified in the bidding document that the evaluation of the proposals would be done in compliance with Section 4(1) of the PPDPA Act to ensure the achievement of transparency, fairness, honesty, competition among Bidders, fair and equitable treatment of all Bidders, promotion of integrity, achievement of environmental, social and economic requirements of the procurement law.

Bidders were also advised that if successful, they would be required to enter into a contract with ACZ which would conform to the requirements of Sections 78 to 89 of the PPDPA Act.

The PMU noted and made the following findings on the tender:






