1.0 Introduction

A direct method of procurement was used according to Section 33 of the Public Procurement and Disposal of Public Assets Act [Chapter 22:23]. The tender was flighted on 02 June 2025 and closed on 2 July 2025. One bidder responded to the tender.

1.1 Evaluation of Bids
