1.1 The meeting commenced with the Procurement Manager leading an opening prayer.

- 2.1 The Chairperson welcomed all members of the evaluation committee and handed over to the Procurement Manager for briefing.

- 2.3 The tender was for Job evaluation services where the Ministry of Local Government and Public Works requires all councils to have conclude the job evaluation by 31 December 2025, hence making the project a high priority.
- 2.4 The budget is above US\$50,000.00, hence for consultancy services, there is need for a two-stage process where an Expression of Interest is called as Stage 1 and Request for proposal for shortlisted bidders be done as stage 2.

- 2.6 It was noted the eGP system did not allow bidders to submit bids without inputting financial information, hence the Procuring entity opened the financial template for Price

Bid from PR and issued an addendum instructing bidders to input a zero (0) cost so as to submit the bids as there will be no financial evaluation at this stage. The Procuring entity also advised bidders through the same addendum that if a bidder had already submitted with cost, the bidder will not be penalized as the financial bids will not be evaluated. Hence all compliant bids reaching financial evaluation Stage will be shortlisted for Stage 2, the Request for Proposal.

- 2.7 The Procurement Manager further stated that the tender evaluation will consist of 3 stages of evaluation in which failing at a stage disqualifies the bid from going to next stage;
- (i) Preliminary examination for administrative and eligibility compliance
- (ii) Technical evaluation for technical compliance

- ❖ Bidder submitted trade reference letter for client and employee surveys not trade reference letters related to our required consultancy service of JOB EVALUATION purposes and at the same time bidder submitted 6 of his trade reference letters that are referenced to an individual work at another company that was KUBASA HUMAN CAPITAL SOLUTIONS CONSULTANTS, THIRD EYE AFRICA CONSULTING GROUP and DISTINCTIVE CONSULTANCY SERVICES at that period of time, instead of the actual bidding company being SIXTH SENSE CONSULTING.
- ❖ Bidder's company was incorporated on 12th of September 2024. Procuring Entity administrative requirement of is a 5-year operating experience of the bidding company, hence the bidder is not compliant to the requirement.
- . Outcome: Not compliant
- **Decision:** FAIL: Disqualified from further evaluation.

3.1.2 INTERNATIONAL COACHING & MENTORING FOUNDATION

- ❖ Bidder submitted a NOTARIAL TRUST DEED that doesn't indicate that he/she offers our required consultancy service of JOB EVALUATION SERVICES and most of his trade references are of strategic planning purposes, facilitated training in customer service excellence, leadership development training and results-based performances instead of JOB EVALUATION SERVICES references.
- Outcome: Not compliant
- **Decision**: FAIL: Disqualified from further evaluation.

3.1.3 INDUSTRIAL PSYCHOLOGY CONSULTANTS
