## 2 EVALUATORS' KEY FINDINGS

### Eng. Tinashe Mutetwa

- Verified full tax and compliance submissions by Mashwede Diesel Services but noted comparatively **high pricing**.
- **Bydowell Investments** met **all statutory and municipal compliance** requirements.

### Ms Kudzai Kaseke

- Observed that **Mashwede Diesel Services** lacked adequate lease verification.
- **Mollitia Trading** failed multiple statutory requirements (licence, lease, fiscalisation).
- **Bydowell Investments** provided complete and verifiable documentation.

### Mr Ian Sibanda

- Independently confirmed **Bydowell's full compliance**.
- **Mollitia Trading** flagged as **non-compliant on three core criteria**.

#### 4 CHAIRMAN'S ANALYSIS

- All three evaluators reached **consensus** that **Bydowell Investments** is the **only fully compliant bidder** across all evaluation categories.
- **Mashwede Diesel Services**, while largely compliant, failed **consistency in lease documentation**.
- **Mollitia Trading** was found **non-compliant on three critical statutory requirements**.
- From a pricing and technical compliance standpoint, **Bydowell Investments submitted the lowest responsive bid**, with all documentation to standard and within budget.
