



TENDER EVALUATION REPORT:

SUPPLY AND DELIVERY OF A TOYOTA HILUX DOUBLE CAB

BAZDOMCOM16/TD/ 2024

Evaluation of Bids.

Bids were evaluated using the following methodology as was indicated in the bidding for the supply and delivery of a Toyota Hilux double cab 4x4, automatic transmission BAZDOMCOM16/2024.

1. Scope of work-supply and delivery of Toyota Hilux double cab for the Broadcasting Authority of Zimbabwe through a Competitive bidding procurement method.
2. Tender Process - requirements were advertised in the Government gazette on 5 July 2024 and the Sunday Mail on 7 July 2024 and closing on 2 August 2024.
3. Budget – Cabinet authority approved an estimated budget of US\$66 490.00 in February 2023 and the Authority’s estimated budget was US\$87 500.00 for 2024 procurement period.
4. **Preliminary examination** to confirm that documents required have been provided, to confirm the eligibility of bidders in terms of section 28 (1) of the Regulations and confirm that the Bid is administratively compliant in terms of section 28 (2) of the Regulations.

5. Eliminated tenders;

Balidson Resources and Capital Equipment T/A ACG Auto, Duly Holdings Limited, and Byword Trading did not have Toyota dealership certificates and their vehicles cannot be traced back to Toyota Zimbabwe in the event of technical faults. Their vehicles cannot be traced back to Toyota Zimbabwe therefore there was a possibility of them being grey imports. Bids failing any stage were eliminated and not considered in subsequent stages.




