RE: REQUEST FOR REVIEW BY THE SPECIAL PROCUREMENT OVERSIGHT COMMITTEE (SPOC): TENDER NO. TIMB/BM/011/2024 -FRAMEWORK AGREEMENT FOR THE PROVISION OF BUILDING REPAIRS AND MAINTENANCE SERVICES

Your minute dated 19 June 2024 refers.

At the Special Procurement Oversight Committee (SPOC) Meeting No. 22 of 2024 held on 04 July 2024, Members observed the following: -

- The Accounting Officer's procurement process was for a Framework Agreement for the Provision of Building Repairs and Maintenance Services.
- The Accounting Officer adopted the Framework Agreement method in line with section 21(2) and section 30 of the Public Procurement and Disposal of Public Assets (PPDPA) Act [Chapter 22:23], as read with section 11 of the PPDPA (General) Regulations whereby suppliers will be engaged through call-off orders on an "as and when required" basis for the Building Repairs and Maintenance Services.
- The Accounting Officer advertised the tender in line with section 38 (2) of the PPDPA Act and a sole bidder participated in the tender.
- Clause 1.18 on page 14 of 19 of the Standard Bidding Document indicated that the Framework Agreement will be a Closed Framework Agreement.
- The Accounting Officer was recommending to cancel the tender due to the fact that there was a sole response on the process whereas section 4 of the SBD indicated that there will be a minimum of three (3) suppliers and a maximum of five (5) suppliers required on the Framework Agreement.
- The Accounting Officer was recommending to cancel the tender due to non-responsive bids received and insufficient number of bids received in line with section 42 (1) (d) of the PPDPA Act.

Accordingly, the SPOC through SPOC RESOLUTION 0428 of 04 July 2024, having reviewed the Accounting Officer's submission in terms of section 54 (10) of the Public Procurement and Disposal of Public Assets (PPDPA) Act [Chapter 22:23], RESOLVED on Tender No. TIMB/BM/011/2024 as follows: -
