

Accordingly in terms of the Public Procurement and Disposal of Public Assets Act [Chapter 22:23] section 55 (2a) as read with the Public Procurement and Disposal of Public Assets (General) Regulations Statutory Instrument 5 of 2018 section 33(2), we advise that those were the successful bidders.

However in terms of the same Act, other tenderers aggrieved by this decision have a right to appeal against the award by lodging a written notice with the Chief Medical Officer of Chitungwiza Central Hospital and Chief Executive Officer of Procurement Regulatory Authority of Zimbabwe (PRAZ) within fourteen (14) days from the notification date.

After the fourteen (14) day period if there is no challenge, winning bidders can proceed and enter into the necessary formal procuring contract with Chitungwiza Central Hospital
