However, in terms of the Public Procurement and Disposal of Public Assets Act, [Chapter 22:23], section 73, other bidders aggrieved by this decision have the right to appeal by lodging a written notice with the procuring entity within fourteen (14) days from the day which the appellant is notified of the decision that is subject to appeal.

Against this background, Omni Africa and Zimbabwe Human Rights Commission will sign a formal contractual agreement on 16 October 2024 at ZHRC Offices, 144 Samora Machel, Harare at 1000hrs (local time) provided that there is no bidder who challenges this procurement decision within the prescribed 14 days period.
