FINDINGS

Out of six companies five failed to meet all mandatory_requirements and one was fully compliant and that is Glentronics Ltd

On the technical aspect, Packlead Investment, Ensureplus Distributors, Primeval Pvt Ltd, Glentronics and Byword Trading were all compliant.

The evaluation on the financial aspect, four are competitive and EnsurePlus was the one that meets the least price to tender specifications with a price of US\$6 500.00, followed by Primeval, Mandikonewa (although it did not meet technical specifications fully), Packlead and last but not the least Glentronics respectively. Byword trading prices were on the high side and not within the council's budget as it was manufactured in 2020. Due diligence on the condition of the cars and technical inspections will be conducted before the awarding of the Tender.

AWARD RECOMMENDATIONS

The evaluation committee unanimously agreed the Tender be cancelled since the bid validity had expired, since the council requisitionist left the council before concluding the process and did not hand over rights to the next individual and due to non-availability of funds.

The recommendations from the committee were to retender and at a later date.

6. SELECTION OF A SERVICE PROVIDER FOR THE SUPPLY AND DELIVERY OF A POOL VEHICLE TENDER NO. EHPCZ/G&S2024/APP12

Out of six companies five failed to meet all mandatory_requirements and one was fully compliant and that is Glentronics Ltd

On the technical aspect, Packlead Investment, Ensureplus Distributors, Primeval Pvt Ltd, Glentronics and Byword Trading were all compliant.

The evaluation on the financial aspect, four are competitive and EnsurePlus was the one that meets the least price to tender specifications with a price of US\$6 500.00, followed by Primeval with USD 6800, Mandikonewa (although it did not meet technical specifications fully) with USD 7 333, Packlead with SD 8000, Glentronics USD 8 500 and Byword with USD 22 550. The meeting agreed to offer the Tender to Glentronics due to the following reasons:

- Fully compliant with 9/9 of the requirements
- The vehicle year of manufacture not very old.
- The price is within the budget range

7. WAYFORWARD

Although Glentonic Company was successful, the evaluation committee unanimously agreed to cancel the tender since the bid validity had expired due to unavailability of funds.

The committee resolved to retender and at a later date.
