**RE: REPORT ON EVALUATION OF TENDER NUMBER BINMUN DW 01/2024 –
SUPPLY AND DELIVERY OF BRICKS AND CEMENT FOR CHIPADZE
STADIUM**

BACKGROUND

The invitation to tender was done on the 16th of August 2024 through a tender notice in the Government Gazette, The Herald on the 19th of August 2024 and subsequently on Procurement Regulatory Authority of Zimbabwe (PRAZ) website <https://egp.praz.org.zw/>. Bidders downloaded the document on the Electronic Government Procurement System (eGP.<https://egp.praz.org.zw/>) and also submitted their bids on the same website. The tender

closed on the 13th of September 2024. Sixteen (16) bidders submitted their bids on the Electronic Government Procurement System (eGP.<https://egp.praz.org.zw/>).

TENDER OPENING

Tender opening commenced at 10AM, with representatives from some of the bidders free to witness it online. The following are the outcomes of the Tender Opening

The tender opening procedure ended with the bidders' representatives being excused

TENDER EVALUATION

Bids were evaluated using the following criteria as set out in the ITT Document:

1. **Preliminary examination** to confirm that all documents required have been provided, to confirm the eligibility of Bidders in terms of section 28(1) of the Regulation and to confirm that the Bid is administratively compliant in terms of section 28(2) of the Regulation.

2. **Technical evaluation** to determine their substantial responsiveness to the specifications in the Statement of Requirements;

3. **Financial evaluation** and comparison to determine the evaluated price of Bids and to determine the lowest evaluated Bid.

PRELIMINARY EXAMINATION

- The evaluation committee noted that Rudmod Development, Bromel Hardware Pvt Ltd, Nyamweda Investments Pvt Ltd, Duo Pole Enterprises Pvt Ltd, Eunidar Investments Pvt Ltd, Adcrap Pvt Ltd and Stielcon Investments, passed the preliminary examination stage.
- Pell Engineering Pvt Ltd failed to submit a signed traceable reference.
- Lunley Investments failed to submit a signed traceable reference and submitted an irrelevant PRAZ category.
- Farvinn Investments failed to submit bid submission sheet and bid validity.
- Skywalk Investments Pvt Ltd submitted an expired NSSA certificate and submitted an acceptance letter in place of a signed traceable reference.
- Tsalaki Investments submitted an irrelevant reference.
- Matowe Enterprises P/L failed to submit a signed traceable reference.
- Bright Elephant Investments provided a reference without a date.
- Tanaka Macmillan Enterprises failed to submit a signed traceable reference.
- Privian International submitted an irrelevant PRAZ registration certificate category.

The evaluation committee recommended that Rudmod Development, Bromel Hardware Pvt Ltd, Nyamweda Investments Pvt Ltd, Duo Pole Enterprises Pvt Ltd, Eunidar Investments Pvt Ltd, Adcrap Pvt Ltd and Stielcon Investments, proceed to the next stage of technical evaluation since they satisfied all the preliminary examination requirements.

TECHNICAL EVALUATION

The evaluation committee noted that Bromel Hardware Pvt Ltd, Duo Pole Enterprises Pvt Ltd and Stielcon Investments satisfied the specifications in the statements of requirements and delivery period as has been requested in the Invitation to Tender Document (ITT). Rudmod

Development, Nyamweda Investments Pvt Ltd, Eunidar Investments Pvt Ltd and Adcrap Pvt Ltd, failed to confirm 5 days DDP delivery period. Hence, the evaluation committee recommended that Bromel Hardware Pvt Ltd, Duo Pole Enterprises Pvt Ltd and Stielcon Investments bids proceeds to the last and final stage of financial evaluation.

FINANCIAL EVALUATION

Bromel Hardware Pvt Ltd, Duo Pole Enterprises Pvt Ltd and Stielcon Investments bided for **Lot 1** for Cement Standard Bricks and **Lot 2** for Cement 50 kgs (42,5%). Bromel Hardware Pvt Ltd quoted USD \$ 60, 000.00; Duo Pole Enterprises Pvt Ltd quoted USD \$ 19, 620.00 and Stielcon Investments quoted USD \$ 21, 000.00 for Cement Standard Bricks. Bromel Hardware Pvt Ltd quoted USD \$ 10, 000.00; Duo Pole Enterprises Pvt Ltd quoted USD \$ 10, 668.00 and Stielcon Investments quoted USD \$ 10, 000.00 for Cement 50 kg (42,5%).

RECOMMENDATION

The evaluation committee recommended the award of supply and delivery of 80 000 Cement Standard Bricks to Duo Pole Enterprises Pvt Ltd as being the lowest bidder to specification.

The evaluation committee recommended the award of supply and delivery of 250 Cement 50 kg (42,5%) to Bromel Hardware Pvt Ltd and 250 Cement 50 kg (42,5%) to Stielcon Investments as being the lowest bidders to specification.
