## TECHNICAL REQUIREMENTS AND RECOMMENDATIONS

- > The committee agreed that the five bidders met the requirements and should proceed to stage two which is the technical compliance stage.
- ➤ Garbage Trolley: It was agreed that all 4 bidders were technically compliant on all items' technical specifications and requirements. Phamacetichem was compliant on all other items except on Garbage trolley where they quoted what was in their stock without giving much information.
- > All bidders except Nemchem managed to quote all the items provided.
- The committee agreed to call in the Mr. Chavhunduka under Domestic Department as the user to clarify on technical specifications on 200L bins.
- > Brush cutter heads: The committee agreed that the brush cutter heads had no specifications. Therefore the committee agreed not to award to any supplier.
