However, in terms of the Public Procurement and Disposal of Public Assets (PPDPA) Act Chapter 22:23 section 73(3) as read together with S.I.5 of 2018 Procurement Regulations, other tenderers aggrieved by this decision have a right to appeal against it by lodging a written notice with the Accounting Officer of Chitungwiza Central Hospital and Chief Executive Officer of Procurement Regulatory Authority of Zimbabwe within fourteen (14) days from date on which the appellant was notified of the decision that is subject of appeal.
